# CAMPAIGN AGAINST FEMALE FETICIDE AND PROTECTION OF GIRL CHILD



With continuation of its ongoing national campaign for the protection of Girl Child, Deep organized a national seminar on this issue on 11th October 2019 in Constitution Club of India. Dr. Rashmi Singh Secretary NDMC was the Chief guest. Other dignitaries were, Shri Vikram Dutt, Senior Educationist and Social Activist, Shri M.M. Vidyarthi, Former Member, Delhi Commission for Protection of Child Rights,

Varun Pathak Consultant MOWCD Govt. of india, Prabodh Kumar and Sarika Verma Advocate Supreme court of India among other dignitaries. In this seminar all the dignitaries present on stage talked about the plan and policies of government. Men and women from all walks of life actively took part in the discussion on PCPNDT Act and its proper implementation. The problem of decline in sex ratio is very grave in almost all over India and people still prefer son over daughter.

Along with the national seminar Deep had organized all over the year various awareness programmes through rallies, street plays and group interaction with people in the states of Jharkhand, Bihar, Uttar Pradesh, Madhya Pradesh and in National Capital Region of Delhi. While awareness generation our volunteers also distributed posters on importance of girl child and on the laws among participants. We also organized community meetings and workshop to make them aware about the importance of girl education.

Deep is always focused for the promotion of education, gender sensitization and promotion of women well being through its campaigns on ground level across the nation because we understand that without empowering its other half of the population true development cannot be achieved. Therefore Deep is working for this cause relentlessly.

## **BITIYA GAURAV AWARD**

In continuation of Campaign against female feticide and protection & promotion of girl child and well-being of women Deep organized its annual Bitiya Gaurav Award to encourage all girls and women to fulfill their dreams through our annual Bitiya Gaurav Award started in 2017. Deep organized its third Bitiya Gaurav Award On 11th December 2019 at Constitution Club of India, Rafi Marg, New Delhi. Shri Shyam Jaju (Vice chairmen of Bhartiya Janta

# WOMEN EMPOWERMENT & DEVELOPMENT PROGRAMME



Women are the half of the society without whom we cannot imagine of this world. Women are known as nature who nurture their family through her love and care. Yet they are not respected in their home for their work and don't have much say in family matters. They face discrimination in their daily life ,such as from getting nutritious food to basic education. All these shows that our society is still behind in terms of providing them equal opportunities which undermines their important role. There is saying that if we educate a woman so we are educating the whole family but if we are educating a man then we are just educating an individual. Hence the role of civil society is very much needed. Therefore, in order to make our country great again women empowerment and girls education needs an urgent attention.

Keeping all these issues in mind Deep Welfare Organization is continuously working for their upliftment by capacity building programmes, Deep is relentlessly working for awareness generation. Such as legal awareness, about their constitutional and fundamental rights through direct interaction in community with the help of our team members in Bihar, Jharkhand, rural areas of Delhi, Madhya Pradesh and Uttar Pradesh. To improve their socio- economic condition Deep provides them various kinds of vocational training, like;-beautician, computer training, stitching at their vocational training centers. We teach them about the importance of small savings.

To make them self reliant Deep have also formed various self help groups in which women helps each

other and provides them financial assistance through micro credit and inter loaning amongst them.

Deep have conducted community meetings in local areas with its volunteers where we taught them about sexual violence, dowry system, child marriage, domestic violence and how they can raise their voice against any kinds of violence. We shared many helpline numbers with them and our volunteers also shared their contact numbers to reach out whenever they are in distress.

To empower them economically we have formed 10 SHG'S so that they can learn about the savings and can do help of each others.

# **VOCATIONAL TRAINING & SKILL DEVELOPMENT**





With second largest country in terms of population India is leading in youth force in world. Youths are full of new energy and enthusiasm with new ideas and potential. Their energy should be channelizing in a right direction through proper training and development programmes. Especially when the crises between the unemployment and self employment are at its high. Developing skill and inculcating them is the best way through which they can contribute in the development of nation.

In order to make them self independent Deep is imparting vocational training to young girls and women through its vocational training centers such as-Beauty parlor,

computer training and stitching. Our objective is to provide them employment and enhance their earning capacity so that they could become economically & socially empowered.


Many girls of our skill training center are self independent and they are running their own shops and are engaged in small business.

All the young girls and women of our vocational training centers participate enthusiastically in all the learning activities of organization.

# CHILD EDUCATIONAL & DEVELOPMENT PROGRAM

Through the various program implementations Deep Welfare organization have found that, violation of Child Rights is rampant due to lack of awareness about the child rights & importance of education amongst the parents and ignorance of the government primary stakeholders. A large number of child laborers have been found in our target areas. They are engaged in different kind of laboring and engaged with household works. The female children are extremely neglected and majority are drop out from regular school. Malnutrition among the younger children and anemia among the adolescent's girls is high. Illiteracy, early marriage, early & repeated pregnancy, number of children, early old age and early deaths are the normal fate of the girls/women. Obviously extreme poverty of the families is the basic cause. Without having food security how majority families will think of education and proper rearing of their children? The issues of the children have not been addressed due to various reasons.

Indian Constitution gives right to education (Article 21A) for every child which is a fundamental Right. But despite this provisions no states has achieved 100% children enrolments in school till now. Large numbers of children's are away from school. To ensure education for every children Indian govt. enacted new law namely Right to Education Act in the year 2010 but still no big changes have been occurred at the ground level. Dropout rate has been improved little bit but it is not sufficient. After going through Govt. data and ground reality, DEEP is running different types of Educational programs in the national capital Delhi, Jharkhand, Uttar Pradesh, Madhya Pradesh & Bihar. Deep is running Non-Formal Education (NFE) centre from last 12 years at Sangam Vihar, Jharoda, North Delhi. Children joined in our centre have been empowered in various skills, 75% children are girls and belong to minorities who were not going to any school. They work with their parents and parents don't send them to school. There is no any Government School at Sangam Vihar, one MCD School is situated in Jharoda and Wazirabad, there are many small private schools but here parents are not economically strong to pay the exorbitant fee for their children's education. Analyzing the situation DEEP started Non-Formal Education and our members visit house to house to tell them about the importance of education & convince parents to send their children in centre for only two hours. Initially Some parents were not ready but the counseling most got agreed for giving better environment to their children. We also invited school going children's after 6 month 50% children



got admission in School. But some children are still coming to centre. In the above mentioned target communities about 120 families are living, they don't have Shelters, Rations card, Voter cards and they are living in makeshift home. Their children are not attending any schools. Parents are busy in rag picking. Our team use to visit residential sights of rag-pickers and called meeting of rag-picker parents. We heard the problems and tried to find out solution so that their children could get education. A aware father was much concerned about children education. He had done a lot in gathering parents and preparing list of children who do not go to school. But all parents wants to set up centre in same sight and after much effort no one provided place for running centre. Every land owner wants huge money but DEEP was not in a condition to hire expensive land neither their parents were in conditions so that they could support us.

# Tata Toyo – Child Development Activity Report Jamshedpur & Barabanki.

In 2019 Deep Welfare Organization has started a pilot project with the collaboration of Tata Toyo Radiators Ltd. For child development in FUMS, Barmamines, Jamshedpur, Jharkhand & in the primary school Khasparia, Barabanki district, UP. School operated from preprimary to class 8th around 140 students studying at schools in different classes Of Jamshedpur and 100 in Khasparia, Barabanki, UP.

School situated in middle of urban slum, studying students belongs from weaker section

of society. School have proper infrastructure, but lots of problems like lack of teachers, lack of sensitization in parents regarding educational facilities and many more.

With need of improving educational support to students of Foundry union middle school, Jamshedpur & in the primary school, Khasparia, Barambanki Taco CSR and Deep welfare organization started join initiative at school from October 2019.

Proceeding of Activities Conducted: After the initial interaction of Taco official & Deep welfare representatives with principal and school management, activities with children started at school. CSR activity focused on educational and extracurricular enhancement of children's through different activity. During the CSR work during the period of Oct 2019-March 2020 many curricular and extracurricular activities are organized at school. During the sessions various sessions on Hindi learning, English Learning, Maths Learning, General awareness, Sanitation and Hygiene, Art & Craft Sessions, Sports activities, Computer learning and many more activities conducted.

The names of major activities are Celebration of 150th Gandhi Jayanti Celebration of Children's Day Know your "Child Parliament" training session "SunaoKavita" programme, "Swachchta Hai Jaruri" program, "English Challenge" program, "Rapid Math's" program, Annual Sports Day ,Computer and internet Literacy, "KahnaiyanPanchatra Ki", Activity with Primary Children's, Know your Freedom Fighters, Sports Training Session, Film Screening Show, Drawing and Painting workshops, Nukkad Natak Training workshop, Art and Craft Workshops, Computer Learning Classes, Mental Math's and Extra Curricular activities:- Parent Interaction, Covid 19 Awareness Sessions, Farewell of Children.

# HEALTH AWARENESS PROGRAMME



To provide health services to all its citizens is the state responsibility. Without making its every citizen healthy we can't imagine of a healthy nation. Equal access to health service is the right of all the citizen because it is a basic necessity of every individual. Keeping this in mind Deep Welfare Organization is working on the health policies and schemes, launched by the government of India to generate awareness among all specially Deep is working with the underprivileged community of society. Deep is engaged in programmes to provide health services to the lower strata.

According to WHO India spends only 1.4% of GDP on health less than Nepal and Sri Lanka and 70% of the overall household expenditure on health is in the country is on medicine. Lack of access to proper healthcare is a major problem in India and to address the issue, the government has introduced many healthcare schemes over the years, such as under the National Health Mission the aim is to make healthcare more accessible and affordable for all sections of the society.

Our honorable PM has launched Ayushman Bharat Yojna/ Pradhan Mantri Jan Arogya Yojna (PMJAY), Pradhan Mantri Bhartiya Janaushadhi Pariyojna (PMBJP) and Rashtriya Arogya Nidhi (RAN), Deep is continuously working on these schemes.

There are the Reproductive, Maternal, Newborn, Child & Adolescent Health program, Janani Shishu Suraksha Karyakram (JSSK) and Rashtriya Bal Swasthya Karyakram for women and children. This includes free services to pregnant women before & after childbirth in government institutions, early identification/intervention of children's birth-defect, diseases and disabilities. Since its inception Deep is a part of pulse polio campaign spread awareness among all locals about the importance of polio drop- Do Boond Jindagi Ki. Deep also organised the regular health camp for school children in the Primary School Khasparia Barabanki, UP and FUMS Burma Mines, Jamshedpur, Jharkhand.

We are engage to nutrition, immunization and proper nutrition of mother and child through our awareness campaigns. In the states of Jharkhand, Bihar, Uttar Pradesh, Madhya Pradesh and Delhi Deep's volunteers are directly working among needy people on ground level over health issues.

# HIV/AIDS AWARENESS PROGRAM

Due lack of to and awareness illiteracy among the poor and common people India has not yet achieved its aim of HIV/AIDS free nation. first case HIV/AIDS in India was detected in 1986, since then it has spread in almost every state of India.

India has the third largest HIV epidemic in the world. In 2017, HIV



prevalence among adults (aged 15-49) was estimated 0.2% which equates to 2.1 million people living with HIV. The epidemic is concentrated among key affected populations.

However, a number of issues including HIV- related stigma, relatively low levels of status awareness among people living with HIV and weak links between diagnosis and treatment means progress is not moving as quickly as hoped.

It should be the responsibility of everyone to make promise and take precautions to stop spreading HIV/AIDS awareness is the key of prevention. Therefore, Deep is relentlessly engaged in generating



awareness from last 13 years. Our organization is playing a pivotal role in mass campaigns through IEC campaigns among communities and other high risk groups.

Deep organized a rally in Bihar, Jharkhand, UP,MP and Delhi among the migrant workers, youngster and women where we discussed about HIV/AIDS and its available treatments.

We made them aware how HIV/AIDS don't spread through mere touch, with eating together and talking. Deep educated HIV/AIDS patients about the importance of taking care medicine and regular checkups from last 13 year. Deep is working in this field to generate awareness among common masses and to give them true knowledge.

# PROGRAM FOR SENIOR CITIZENS

defines Indian Law senior citizen "a person being a citizen of India, who has attained the age of sixty years or above". Deep Welfare Organization has been actively working for the well being and care cause of senior citizens since its inception. Deep reach out to all those senior citizens who are being neglected by their families and society and deprived of their basic needs. Deep has organized several seminars, workshops and



other activities in the past also for senior citizens. The boundary of old age cannot be defined exactly because it does not have the same meaning in all societies. People can be considered old because of certain changes in their activities or social roles. Also old people have limited regenerative abilities and are more prone to disease, syndromes, and sickness as compared to other adults. The medical study of the aging process is called gerontology and the study of diseases that afflict the elderly is geriatrics. The United Nations World Assembly on Ageing, held at Vienna in 1982, formulated a package of recommendations which gives high priority to research related to developmental and humanitarian aspects of ageing (United Nations, 1987). The plan of action specifically recommended that "International exchange and research cooperation as well as data collection should be promoted in all the fields having a bearing on ageing, in order to provide a rational basis for future social policies and action. Special emphasis should be placed on comparative and cross cultural studies in ageing".

In India the size of the elderly population, i.e. persons above the age of 60 years is fast growing. According to population census 2011 there are nearly 104 million elderly persons in India. For a developing country like India, this may pose mounting pressures on various socio economic fronts including pension outlays, health care expenditures, fiscal discipline, savings levels etc. Again this segment of population faces multiple medical and psychological problems. There is an emerging need to pay greater attention to ageing-related issues and to promote holistic policies and programs for dealing with the ageing society. Deep gives the service of care-takers to various old and infirm persons.

Keeping these factors in mind, DEEP has kept its focus on Senior citizens also. In current year, DEEP has run project for welfare of senior citizens, seminars, workshops, awareness drives, and legal awareness programs for senior citizens, knowledge exchange programs, literacy programs etc. in association with likeminded NGOs, agencies and organizations. DEEP has also conducted several sensitization programs to Bridge Intergenerational Gap.

# **RURAL DEVELOPMENT & AGRICULTURE**



DEEP is working to improve the quality of life and economic well- being of people living in rural areas and among marginal communities. To achieve this agenda our organization is working towards infrastructure building in rural communities, such as- Entrepreneurship, physical infrastructure and social infrastructure. All these play an important role in rural development. Rural development is also about locally produced economic development strategies.

Agriculture is one of the most important part in rural development and sustainable livelihood approach. As on today, our agriculture systems seeing side effect of pesticides and chemical using in farming. Promoting sustainable livelihoods for the poor is a key challenge in development policy and action in India. Deep Welfare Organization is working to enhance the quality of life of target population. We are continuously generating awareness through ours program known as Krishi samadhan, Kisan Sabha, help of local Panchayats through direct communication in groups with locals. This type of programs has organized in various district of Bihar and in Jharkhand. Our experts told to farmers how organic food and farming are safe than pesticides farming. Several surveys and studies have done to examine and compare conventional and organic systems of farming.

Organic farms do not consume or release synthetic pesticides into the environment some of which have the potential to harm soil, water and local terrestrial and aquatic wildlife. Organic farms are better than conventional farms at sustaining divers' ecosystem, population of plant and insect as well as animal. When calculated either per unit area or per unit of yield, organic farms use less energy and produced less waste, ex- waste such as packaging materials for chemical during the year we have supported farmers providing seeds for cultivation.

Deep organized awareness programme among farmers about Farmer Producer Organization and how they can raise their income through this FPO (Farmer Producer Organization).

# ENVIRONMENT PROTECTION, WATER & SANITATION PROGRAM

Global warming is the most serious issue around the world. Deforestation is very high in world and water scarcity is leading the world towards the third world war. Sustainable livelihood is the need of hour and to achieve this awareness among masses is must. Keeping this in mind Deep is engaged in generating awareness among people through its rallies, nukkad sabhas, nukkad natak and raising its voice in its national seminars. At the same time Deep




discussed about forest rights act. So that the people of the area get motivate and they can use the non-timber forest products without cutting the trees. The forest protection committees also strengthening through this camp.

Today global warming affects our lives and climate change is destroying our life through natural calamity like Flood, Drought, Tsunami etc. Some time ago when environmentalists and activists warned that if we will not save environment then life will be more difficult in future. Deep is running campaign to protect and clean environments. We use to aware Community peoples in every meeting and people gathering. We trained our SHG members for protecting environments .Deep is continuously playing a greater role to create awareness through street plays in Campuses of Delhi University about clean rivers and in nearby areas.

Accordingly a set of awareness campaign and action component has been designed in the plan already mentioned above which will be very much useful for the people of the area for promoting forest based livelihood opportunities. Deep trained their SHG members for keeping environment clean. Deep have also launched special program for plantation with school students and in local areas of Jamshedpur & Delhi.
