CAMPAIGN AGAINST FEMALE FETICIDE AND PROTECTION OF GIRL CHILD

In our society a belief that the women and girls are less valuable than men and boys are still prevalent. As per the report of United Nation Population Fund (UNPFA) nearly 4.6 crore (45.8 million) females are missing in India due to son preference and pre & post- birth sex selection practices. Deep Welfare Organisation is working to save our girls and specially to prevent female feticide since its inception. Along with the national seminar over the years various awareness programmes such as issue of female feticide and protection of children from sexual offenses through rallies, street plays and group interaction with people in the states of Jharkhand, Bihar, Uttar Pradesh, Madhya Pradesh and in National Capital Region of Delhi. While awareness generation our volunteers also distributed posters on importance of girl child and on the laws among participants. We also organized community meetings and workshop to make them aware about the importance of girl education. As we are aware that due to pandemic women and girls have been more affected and are in vulnerable condition. Therefore Deep has increased its focus on ground level through its volunteers and organizing community awareness by meetings with anganwadi workers and with local people. Deep is helping in enrolling dropouts girls in school and in this regard we have re-admitted around 12 girls in this year because education is the best weapon through which one can lighten their life so Deep is always focused for the promotion of education, gender sensitization and promotion of women well being through its campaigns on ground level across the nation because we understand that without empowering its other half of the population true development cannot be achieved. Therefore Deep is --working for this cause relentlessly with the help of various stakeholders.



WOMEN EMPOWERMENT & DEVELOPMENT PROGRAMME



A woman plays various role in her life at various stages. She plays a vital role in building a family who as a nature nurture their family through her love and care. Yet they are not getting acknowledgement for carrying out their roles and responsibilities. Every woman face discrimination in her day to day life, such as from not getting nutritious food to basic education. All these issues shows that our society is still behind in terms of

providing them equal opportunities which undermines their important role. As we all are aware that the pandemic has badly affected women and girls across the globe and specially in developing country like India. They have become once again and vulnerable dependent because of pandemic they have lost their jobs or if they have jobs they have been suffering from double burden of work. Many girls have forced into child marriage by their parents . Therefore, in order to make our country great again women empowerment and girls education needs an urgent attention.

Keeping all these issues in mind Deep Welfare Organisation is continuously working for their upliftment by capacity building programmes, Deep is relentlessly working for awareness generation and ensuring no women is afflicted by domestic violence. Such as legal awareness, about their constitutional and fundamental rights through direct interaction in community with the help of our team members in Bihar, Jharkhand, rural areas of Delhi, Madhya Pradesh and Uttar Pradesh. To improve their socio- economic condition Deep provides them various kinds of vocational training, like;-beautician, computer training, stitching at its vocational training centers. We teach them about the importance of small savings. To make them self reliant Deep have also formed various self help groups in which women helps each other and provides them financial assistance through micro credit and inter loaning amongst them.

Deep have conducted community meetings in local areas with its volunteers where we taught them about sexual violence, dowry system, child marriage, domestic violence and how they can raise their voice against any kinds of violence. We shared many helpline numbers with them and our volunteers also shared their contact numbers to reach out whenever they are in distress.



VOCATIONAL TRAINING & SKILL DEVELOPMENT



India is a developing country and the second largest country in terms of population. In order to make the nation self-reliant it is important to make every individual economically viable and self-independent by giving work in every hand.

According to our father of nation vocational training enables the low intelligent students to express their creative side. Vocational training and skill development brings

attitudinal change in an individual and make them aware about the social issues. Especially when the gender biasness still exist in our society and girls are taken to be economically burden on their family. Therefore, Deep welfare organization since 14 years is working to provide vocational training to young girls and women through its vocational training centers such as- Beauty parlor, computer training and stitching in Bhagalpur district of Bihar and National Capital Territory of Delhi where our centers are running regularly. Almost all girls and women held from economically weaker section and want to help their husband and family economically. Making them empower is our social duty. These women and girls are feeling empowered by their skill training and those who have completed their training programme has started their own boutique and beauty parlor or working as a trainer somewhere else.

Deep provide these skill trainings of six months and one year and after completion Deep provide certificates to all girls & women. Deep is relentlessly working towards empowering community women and girls through inculcating the skills.



CHILD EDUCATIONAL & DEVELOPMENT PROGRAMME



Children are most important asset of this society but they are neglected of proper care and love. Children are most vulnerable section as well. These pandemics have deprived them of their rights and were subject to exploitation. Many children have been pushed in child labor due to poverty and girl child in child marriage and majority of them are drop out

from regular school. Malnutrition among the younger children and anemia among the adolescent's girls is high. Illiteracy, early marriage, early & repeated pregnancy, number of children, early old age and early deaths are the normal fate of the girls/women. Obviously extreme poverty of the families is the basic cause. Without having food security how majority families will think of education and proper rearing of their children? The issues of the children have not been addressed due to various reasons.



Indian Constitution gives right to education (Article 21A) for every child which is a fundamental Right. But despite this provisions no states has achieved 100% children enrolments in school till now. Large numbers of children's are away from school. In this tough time of pandemic Deep has ensured that no child is being deprived of education and proper care. After going through Govt. data and ground reality, DEEP is running different types of Educational programs in the national capital Delhi, Jharkhand, Uttar Pradesh, Madhya Pradesh & Bihar. Deep is running Non-Formal Education (NFE) centre from last 15 years at Sangam Vihar, Jharoda of North Delhi. Children joined in our centre have been empowered in various skills, 75% children are girls and belong to minorities who were not going to any school. They work with their parents and parents don't send them to school. Deep was running its regular classes for all those children who don't have smart phones to attend the classes during pandemic. Deep has also work on re- admitting drop out children in schools. Our teacher takes two classes in morning and two in evening. DEEP through is Non-Formal Education deep has made its sure that pandemic should not harm the education rights of children. So that everyone can have access to at least their basic education. Our teachers talk with the parents of all backward community to convince them to send their children for classes which is free of cost.

HEALTH AWARENESS PROGRAMME



As per the judgment of Supreme Court of India "Right to Health is a fundamental right guaranteed under Article 21 of the constitution of India", It includes affordable treatment and it is the duty of the State to make provisions for affordable treatment. Access to affordable and quality health facility is the right of every citizen.

According to WHO report India spend less than Nepal and Sri Lanka on health and 70% of the overall household expenditure on health in the country is on medicines. Lack of access to proper healthcare is a major problem in India. To address this issue, the government has introduced many healthcare schemes over the years, such as under the National Health Mission the aim is to make healthcare more accessible and affordable for all sections of the society. Ayushman Bharat Yojna/ Pradhan Mantri Jan Arogya Yojna (PMJAY), Pradhan Mantri Bhartiya Janaushadhi Pariyojna (PMBJP) and Rashtriya Arogya Nidhi (RAN), In view of this social issue Deep welfare Organisation is continuously working on proper implementation of these schemes so that every needy person can avail the facility provided by government.

In this pandemic time our organization is working on creating social awareness about how everyone's life is connected with our actions. We aware people about importance of wearing face mask and washing hand regularly and therefore, Deep organized hand wash drive in community, distributed face mask and sanitizer among needy people.

A special awareness drive for women and children nutrition amid pandemic was organized. This includes free services to pregnant women before & after childbirth in government institutions, early identification/ intervention of children's birth-defect, diseases and disabilities. Along with these activities we are very careful about the menstrual health of poor women and empower them in this difficult time of pandemic deep distributed sanitary napkins among these women.



HIV/AIDS AWARENESS PROGRAMME



Due to pandemic people affected by HIV/AIDS were marginalized of proper treatment and awareness. Fear, stigma and ignorance is still attached with HIV/AIDS in society. During pandemic there was no effective treatment available for this deadly disease and there was little hope for those diagnosed with HIV, facing debilitating illness and certain death.

India has the third largest HIV epidemic in the world. In 2017, HIV prevalence among adults (aged 15-49) was estimated 0.2% which equates to 2.1 million people living with HIV. The epidemic is concentrated among key affected populations.

It should be the responsibility of everyone to make promise and take precautions to stop spreading HIV. Awareness is the key of prevention. Therefore, Deep is relentlessly engaged in generating awareness from last 14 years in East Singhbhum, Bokaro in the state of Jharkhand, Rohats and Bhagalpur district of Bihar, Burari, in NCT of Delhi, Lakhnow in Uttar Pradesh and Singhrauli in Madhya Pradesh. Our organization is playing a pivotal role in mass campaigns through IEC campaigns among communities and other high

risk groups. We are making it sure that the person affected by HIV/AIDS are not deprived of treatment facility. In this regard mass campaigning is very much important to perish the stigma, fear and ignorance among people, which Deep Welfare Organization is doing through its information, educations and communication cell. Our volunteers are working with community to remove stigma related to HIV/AIDS.



COVID Relief Programme



COVID-19 pandemic has devastating consequences around the world. The year of 2020 and 2021 was severely hit by pandemic which causes harms of many lives. In view of the pandemic Deep Welfare Organization has made it sure that the covid related norms are implemented for which Deep started awareness campaigns in community through poster distribution, nukkad natak, talk with the help of anganwadi workers about how to stay clean, taking proper precautions and creating a safe environment.

We were continuously helping families affected by covid-19 by providing beds in hospitals or necessary medicines and door to door awareness sessions.

Our team distributed dry ration kits among needy people in East Singhbhum, Bokaro in the state of Jharkhand, Rohats and Bhagalpur district of Bihar, Burari, in NCT of Delhi, Lakhnow in Uttar Pradesh and Singhrauli in Madhya Pradesh and Distribution of hand sanitizer & face mask were also done at above mentioned places among the marginalized and weaker sections.

With the support of GMR group Deep has distributed 50 rickshaws in different slums of unauthorized colonies of Delhi for livelihood generation among those who got unemployed due to covid lockdown. Deep is also engaged in creating vaccination awareness through community talks and emphasizing people to get vaccinated at their nearest vaccination sites as soon as possible. Along with this we are working on

eliminating misinformation, propaganda and fake news among people.

We are continuously engaged in building an inclusive and democratic society during and after covid.



PROGRAM FOR SENIOR CITIZENS



“A person being a citizen of India, who has attained the age of sixty years or above” is known as senior citizen as per the Indian Law. Deep Welfare Organisation is actively working for the well being and care cause of senior citizens since its inception. Deep reach out to all those senior citizens who are being neglected by their families and society and deprived of their basic needs. We are making it sure that all senior citizens are getting proper care and continuously enrolling them in Old age pension scheme so that they can get proper nutrition and their day-to-day expenses. Deep has organized several seminars, workshops and other activities in past for senior citizens. Deep organize several activities for them so that they can be engage in self expressing activities. The boundary of old age cannot be defined exactly because it does not have the same meaning in all societies. People can be considered old because of certain changes in their activities or social roles. Also old people have limited regenerative abilities and are more prone to disease, syndromes, and sickness as compared to other adults.”

In India the size of the elderly population, i.e. persons above the age of 60 years is fast growing. According to population census 2011 there are nearly 104 million elderly persons in India. For a developing country like India, this may pose mounting pressures on various socio economic fronts including pension outlays, health care expenditures, fiscal discipline, savings levels etc. Again this segment of population faces multiple medical and psychological problems. There is an emerging need to pay greater attention to ageing-related issues and to promote holistic policies and programs for dealing with the ageing society. Deep gives the service of care-takers to various old and infirm persons.

Keeping these factors in mind, DEEP has kept its focus on Senior citizens also. In current year, DEEP has run project for welfare of senior citizens, seminars, workshops, awareness drives, and legal awareness programs for senior citizens, knowledge exchange programs, literacy programs etc. in association with like-minded NGOs, agencies and organizations. DEEP has also conducted several sensitization programs to Bridge Intergenerational Gap.

RURAL DEVELOPMENT & AGRICULTURE



Since the beginning DEEP Welfare Organisation is making it sure that rural areas must not be deprived in this run of development and therefore, our work is majorly rooted at ground level with special focus on villages because the true meaning of rural development is to make rural areas self-sufficient by developing more economic opportunity which will lead to stop migration of people from rural to urban areas and Deep is working for this cause with focus on improve the quality of life and economic well- being of people living in rural areas and of marginal section. To achieve this agenda our organization is working towards capacity building programme in rural communities, such as- encouraging about Entrepreneurship, creating necessary physical and social infrastructure which plays an important role in rural development and directly engaging with rural people in helping them out about locally produced economic development strategies.

Agriculture is one of the most important part in rural development which contribute 20.2 percentage as per provisional estimates of Annual of National Income, released by National Statistical Office (NSO) and around 41.49 % people are still depended on agriculture and allied activities. Organic farms do not consume or release synthetic pesticides into the environment some of which have the potential to harm soil, water and local terrestrial and aquatic wildlife. Organic farms are better than conventional farms at sustaining divers' ecosystem, population of plant and insect as well as animal. When calculated either per unit area or per unit of yield, organic farms use less energy and produced less waste, ex- waste such as packaging materials for chemical during the year we have supported farmers providing seeds for cultivation.

Therefore, it is the need of hour to make our agriculture sector sustainable As on today, our agriculture sector is being affected by pesticides and chemical using in farming. Promoting sustainable livelihoods for the poor is a key challenge in development policy and action in India. Deep Welfare Organisation is working to enhance the quality of life of target population. Our volunteers are reaching to last miles to generate awareness about natural farming. We are continuously running awareness program known as Krishi samadhan, Kisan Sabha, help of local Panchayats through direct communication in groups with locals. This type of programs has organized in various district of Bihar and in Jharkhand. Our Experts specialized in this sector communicate with farmers in these awareness programmes about knowhow of organic farming.

ENVIRONMENT PROTECTION, WATER & SANITATION

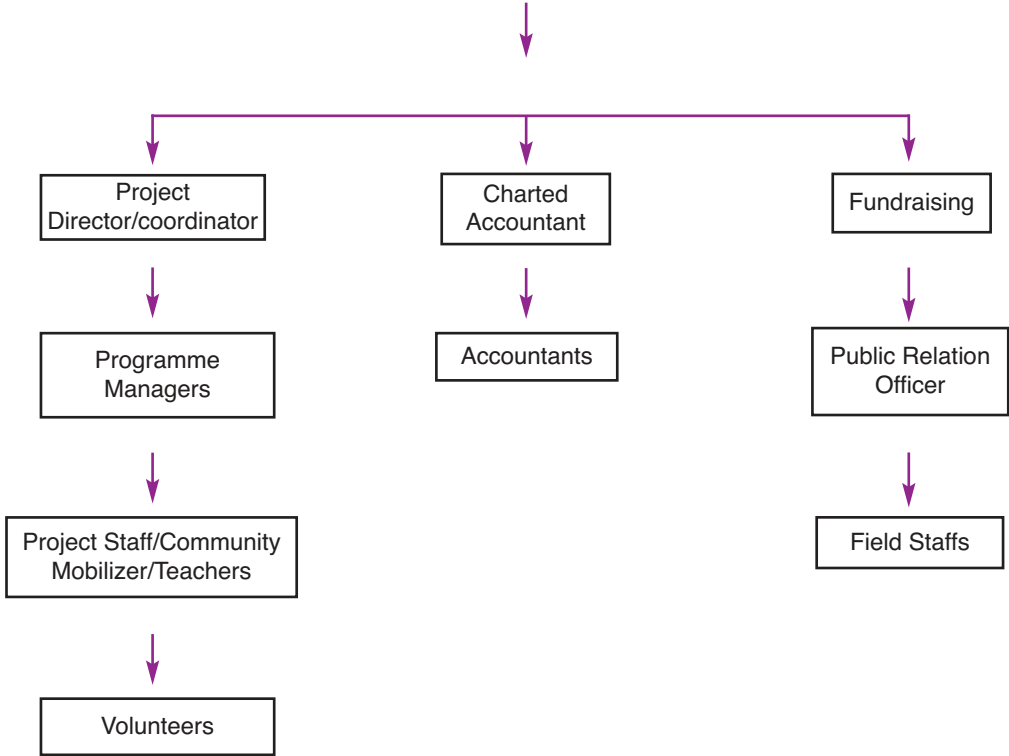

To achieve the target of Sustainable livelihood Deep is running awareness among masses is must through its rallies, nukkad sabhas, nukkad natak and raising its voice in its national seminars. At the same time Deep discussed about forest rights act. We are engaging with community by talks on how personal actions fight climate change. So that the people of the area get motivated and they use the non-timber forest products without cutting the trees. The forest protection committees also strengthening through this camp.

Today global warming affects our lives and climate change is destroying our life through natural calamity like Flood, Drought, Tsunami etc. Some time ago when environmentalists and activists warned that if we will not save environment then life will be more difficult in future. Deep is running campaign to protect and clean environments. We use to aware Community peoples in every meeting and people gathering. We trained our SHG members for protecting environments. Deep is organizing regular awareness program under the project of National Environment Awareness Campaign with the help of Ministry of Environment & Forest from last 14 years. As women plays important part in household activities so it is important to make them part in this and in this regard Deep organized pledge ceremony with community women to save water. Accordingly a set of awareness campaign and action component has been designed in the plan already mentioned above which will be very much useful for the people of the area for promoting forest based livelihood opportunities. Similarly to achieve this target we are assimilating college students to speed up the process.
