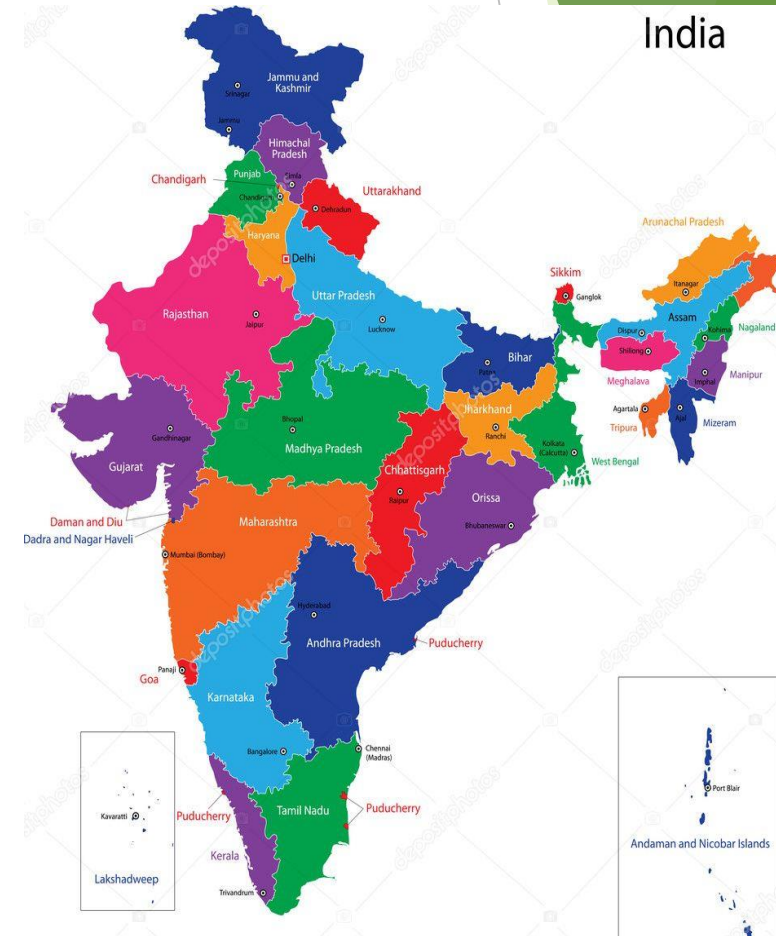

We celebrate “*Jal Gunvatta Parikshan Divas*” to meet the high standard of water quality.

Working to create water supply infrastructure so that every rural household has Functional Tap Connection (FHTC) and water in adequate quantity of prescribed quality is made available.

We are giving training to people at grass root level to create awareness among all.





Deep is working for rural water supply strategy for ensuring potable drinking water security on long-term basis to every rural household and public institutions through gram panchayat, Schools, Anganwadi centre, Health center, wellness centers, etc. Teaching villagers to test quality of their drinking water

Has done household survey on water safety and security.

Creating water sisters in all gram panchayat to who are goes door to door to test water samples,

Creating awareness in community through water talks on significance of water for improvement in quality of life.

Teaching students about good practices such as hand wash, how to use waste water and water conservation.





BEST PRACTICES



Formed “*Gram Jal -Swachhta Samiti*”(water safety committee) in villages from among villagers to implement the JAL JEEVAN MISSION objectives.

Giving training of FTK at district, block & village level.

Water testing sisters in all villagers reach out to schools, panchayat & at anganwadi centres.

Formed “water committees” at grassroots level and regularly training them.

CHALLENGES

- ❖ Taking people in confidence is a biggest challenge.
- ❖ People were not ready to show their documents during family survey, such as ADHAR CARD, PAN CARD & RATION CARD.
- ❖ Many families do not have basic document such as adhar and ration card.
- ❖ Economically well off families are not much interested in this movement.
- ❖ Without the permission of husbands women are not allowed to come forward test water quality.
- ❖ Availability of electricity is a major issue in the road of water testing facilities.
- ❖ Those families who got water connection through JAL JEEVAN MISSION, are getting very insufficient water due to which people are dissatisfied.
